By submitting this application, you agree to abide by the Terms & Conditions for Trade Stand Holders, including compliance with safety, insurance, and event regulations.

Full terms are available below:

THE BIG BUS SHOW 2026 TRADE STAND RULES, REGULATIONS, HEALTH AND SAFETY POINTS.

1. This event is open to the public from 10am to 4pm and set up is available from 730am on the day and from 12pm to 6pm on the day before.
2. All stalls must be staffed, stocked and open to the public by 10am to 4pm on the show day.
3. All vehicles (not exhibiting in the event) to be removed from the show area by 10am, no unloading permitted after 10am. A designated parking area will be advised by our showground staff (normally by the events barn).
4. ALL Exhibitors and trade vehicles must be parked in the designated parking area or within your stand area by 10am.
5. No vehicle movement is allowed on site during the hours of 10am and 4pm.
6. No stall should be dismantled before 4pm.
7. No stand is secure until the payment is cleared, payment is due within 14 days of application acceptance.
Your payment must be made in full at the time of booking.

15. Exhibitors should display their name and address which can be easily seen by the public.
16. Allocation of stands will be to the event managers' discretion.
17. No exhibitor/trader may sub-let any part of the site allocated.
18. Amplification equipment may be used provided it is at a reasonable level and not intrusive to other traders or members of the public.
19. Any exhibitors who bring their own marquee MUST provide a Health & Safety Risk Assessment together with a suitable fire extinguisher.
